

Waiver and Release of Liability

PuzzleQuest, Inc. is an “escape the room” and conference room venue. PQ (PuzzleQuest, Inc) operates themed rooms and could have any of the following in the rooms:

- Uneven Floors
- Water Vapor
- Laser Lights
- Strobe Lights
- Computer Screens with Flashing Messages
- Blinking Signs
- Stairs and Slides

There are no clues that require standing on furniture or forcing anything that does not move easily off of walls, flat surfaces, furniture drawers or floors. The room could require picking up an object weighing no more than 15 pounds. Anyone who cannot or does not wish to use stairs or slides, etc, may call their Game Master and in all cases there is an alternative route that will be provided to proceed in the game. Anyone with seizure disorders, pregnant or any other condition who does not feel safe to be a part of the effects described above should also let their Game Master know and your money will be fully refunded.

In consideration of the risk of injury while participating in Escape Room, and as consideration for the right to participate in the activity, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation at PQ, and do hereby release and forever discharge PuzzleQuest, Inc and the owners, located at 1245 Cedar Rd Unit B, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned activity, including getting to and from an event related to this activity.

I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHERS' NEGLIGENCE, CONDITIONS RELATED TO THE CONDITION OF THE ACTIVITY. NONETHELESS, I ASSUME ALL RELATED RISKS, BOTH KNOWN OR UNKNOWN TO ME, OF MY PARTICIPATION IN THIS ACTIVITY INCLUDING GETTING TO AND LEAVING THIS BUILDING.

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment or facilities occurs as a result of mine or my family's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect or recklessness.

I agree to indemnify and hold harmless PQ against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or anyone else acting on my behalf.

I understand while participating in this activity, I may be photographed. I agree to allow PQ to use my photo, video, or film likeness to be used for any legitimate purpose this authorizing entity decides, and assigns
